

Substance Share Additional Terms

Effective as of June 2, 2020.

These Additional Terms govern your use of Substance Share and are incorporated by reference into the Adobe General Terms of Use ("**General Terms**") located at www.adobe.com/go/terms (these Additional Terms and the General Terms are collectively referred to as "**Terms**"). Capitalized terms not defined here have the same meaning as those terms defined in the General Terms. References to "**Services**" in these Additional Terms are to the Substance Share services. "**Licensee**" means any individual or legal entity that obtains Content from the Services. For the purposes of these Additional Terms, if you post Content to the Services on behalf of a Business, you are a "**Business User**" and all references to "**you**" in these Additional Terms will mean such Business.

1. Licenses to Content. Substance Share is a platform where users can exchange Content. By posting your Content to the Services, you agree to license your Content to Licensees under the Substance Share License 1.0, which can be found online or in Appendix A below.

2. Use of Content. If you post Content to the Services, you understand and agree that (A) Licensees may modify and use your Content in connection with any subject matter (except as restricted by the Substance Share License 1.0); (B) Licensees are not required to provide you attribution when they use your Content; (C) Adobe is not required to provide you attribution for Content you post to the Services; and (D) your Content's metadata may be altered, removed, or added to, without any liability to us or Licensees. We are not responsible for any third party's use of your Content, nor are we liable if a Licensee does not comply with these Terms, does not comply with the Substance Share License 1.0, or otherwise misuses the Services.

3. Your Use of the Services. You may not use the Services as a personal storage repository for your Content. If we determine your use of the Services violates the Terms or our [Community Guidelines](#) (which are incorporated by reference into the Terms) we may remove your Content from the Services or disable your use of the Services at any time, with or without notice to you.

4. Uploading and Managing Content

4.1. Uploading Content. You will follow the upload process described in the Services, but we have the right to reject the upload of your Content to the Services for any reason.

4.2. Managing Content. You may remove any of your Content from the Services at any time, but Licensees who licensed your Content before you removed it from the Services will continue to possess the same rights you granted them at the time of their download, as specified in the applicable license in effect at the time of their download (e.g., Substance Share License, CC BY 4.0, etc.).

Appendix A - Substance Share License 1.0

1. Definitions

- 1.1. **"Work"** means a work of authorship.
- 1.2. **"Contributor"** means the individual or legal entity that posts a Work to Substance Share.
- 1.3. **"Larger Work"** means a new work of authorship that incorporates an unmodified Work.
- 1.4. **"Modified Work"** means a new work of authorship created, at least in part, by modifying the Work.
- 1.5. **"License"** means version 1.0 of the Substance Share License.
- 1.6. **"You"** means the individual or legal entity that obtains a Work from Substance Share.

2. License Grant. Subject to the terms and conditions of this License, the Contributor grants you a perpetual, worldwide, non-exclusive, fully paid up, royalty-free, and irrevocable license to:

- 2.1. Use, copy, and modify the Work;
- 2.2. Create derivative works based on the Work solely in the form of a Modified Work or a Larger Work;
- 2.3. Copy, publicly display, publicly perform, and distribute the Work only as modified into a Modified Work or as incorporated into a Larger Work; and
- 2.4. Sublicense the rights in Section 2(C) through multiple tiers of distribution.

3. Restrictions and Limitations

- 3.1. **Limitations on License Grant.** You may not publicly display, publicly perform, distribute, or sublicense the Work if it has not been (A) modified into a Modified Work; or (B) incorporated into a Larger Work. For the avoidance of doubt, you may not publicly display, publicly perform, distribute, or sublicense an unmodified, standalone copy of the Work.
- 3.2. **Ownership.** The Contributor retains ownership of the Work, and the licenses granted in Section 2 are the only rights granted under this License. You do not receive any additional implied rights or licenses, whether regarding patents, trademarks, or anything else, due to the distribution or licensing of Works under this License.
- 3.3. **Content Restrictions on Modified Works and Larger Works.** You may not publicly display, publicly perform, distribute, or sublicense the Work as part of a Modified Work or a Larger Work that violates any laws, rules, or regulations.

4. Disclaimer of Warranty. The Work is provided "AS-IS." To the maximum extent permitted by law, the Contributor disclaims all warranties, express or implied, including the implied warranties of non-infringement, merchantability, and fitness for a particular purpose.

5. Limitation of Liability. The Contributor is not liable to you or anyone else for any special, incidental, indirect, direct, consequential, moral, exemplary, or punitive damages whatsoever, regardless of cause, including losses and damages (A) resulting from loss of use, data, reputation, revenue, or profits; (B) based on any theory of liability, including breach of contract or warranty, negligence, or other tortious action; or (C) arising out of or in connection with your use of the Work. These limitations and exclusions in this section 5 (Limitation of Liability) apply to the maximum extent permitted by law even if (A) a remedy does not fully compensate you for any losses or fails of its essential purpose; or (B) the Contributor knew or should have known about the possibility of damages.

6. Termination. If you fail to comply with the License, then your rights under the License terminate automatically and without any prior written notice. Upon termination of the License, you must stop distributing and sublicensing the Work as modified into Modified Works or as incorporated into Larger Works.

7. Survival. The following sections of this agreement survive expiration or termination of this agreement: 1 (Definitions), 3 (Restrictions and Limitations), 4 (Disclaimer of Warranty), 5 (Limitation of Liability), 6 (Termination), and 7 (Miscellaneous).

8. Miscellaneous

8.1. If any provision of this License is held to be unenforceable, (A) such provision will be reformed only to the extent necessary to make it enforceable; and (B) the remainder of the provisions in this License will continue in full force and effect.

8.2. The parties to this License are independent contractors. There is no relationship of partnership, joint venture, employment, franchise, or agency created by this License between the parties. Neither party has the power to bind the other or incur obligations on the other party's behalf without the other party's prior written consent.

8.3. This License is the complete and exclusive statement of the mutual understanding of the parties and supersedes and cancels all previous and contemporaneous written and oral agreements and communications relating to the subject matter of this License.
